**1. CALL TO ORDER-INTRODUCTIONS**

Mr. Bench called the meeting to order at 4:07

**2. MINUTES OF MARCH 29, 2011**

ACTION: Motion by Sczerpinaik, supported by Lovejoy, to approve the minutes of March 29, 2011.

DISCUSSION: Mr. Moore indicated one change, that Mr. Niles was representing acting commissioner DePaola at the last MPO meeting.

VOICE VOTE: 6 Ayes, 1 Abstention

MOTION CARRIED

**3. TAC REPORT**

Mr. Siegars provided an update from the TAC, summarizing the TAC's discussion on bike paths, the Regional Transportation Plan, and the Transportation Improvement Program.

The TAC is concerned that Congress may take back earmarked Federal funds from old legislation that remains unobligated. Mr. Wadsworth indicated that Congress was only recapturing unobligated funds from TEA-21 (1998), therefore the Berkshires' existing earmarks were still available for obligation. Mr. Bench assured Mr. Karns that commitments made through the Scenic Byways program were still moving forward.

**4. OPPORTUNITY FOR PUBLIC COMMENT**

Mr. Siegars also indicated that the TAC should begin a funding discussion because driving is less frequent with high gasoline prices, reducing federal and state transportation revenue.

**5. DISCUSSION ON RTP**

Mr. Plachcinski provided a status report on the RTP. He reviewed the chapters, the graphics, fiscal constraint, and the remaining schedule. Mr. Mullen suggested that the economics section contain information about regional production in addition to employment. Mr. Bench said the approach was consistent with MassDOT's current planning efforts and that the June 30<sup>th</sup> deadline for RTP adoption was not absolute. Mr. Karns remarked that air quality conformity and transit financial projections were still outstanding for the draft document. Mr. Bench said that the MPO should confirm the availability of the information with Mr. Wadsworth prior to scheduling the Public Hearing for the RTP draft.

**6. DISCUSSION ON TIP EVALUATION**

Anuja Koirala presented information on the updated TIP selection process and project metrics.

**7. DISSCUSSION AND POTENTIAL RELEASE OF TIP AMENDMENT**

Mr. Kus and Mr. Wadsworth described the TIP amendment that shifted funds for the South St. project through the enhancement program. The MPO discussed potential uses for funds, past and present pitfalls for developing stand-alone enhancement projects. Mr. Bench assured the MPO that the Commonwealth's poor performance of obligating enhancement funds was not because of the Berkshires and there is no longer a Transportation Enhancement steering committee. Mr. Wadsworth mentioned that MassDOT anticipates funding increases in the future, although the current enhancement level was \$153k.

**ACTION:** Motion by Mullen, supported by Lovejoy, to release the TIP amendment, with corrections, for a 15 day review and public comment period.

**DISCUSSION:** Mr. Kus stated that the 15-day public notice option is appropriate for a TIP amendment of this nature, and that the Public Participation Plan is consistent with this approach.

**VOICE VOTE:** 7 Ayes

**8. MEMBER AGENCY REPORTS**

Mr. Frieri provided an update on the status of improvement projects within the region, most specifically projects that changed status or are slated for the FFY2011, including the Ashuwillticook, and engineering design from TEA-21 earmarks.

**9. OTHER BUSINESS**

Mr. Bench discussed his trip to central Asia and his observations on public transportation systems, particularly high-speed rail at 215 mph. He also noted that in some areas the public

transportation capacity was overwhelmed and that he thought the systems were constructed in a manner that may be difficult to maintain over time.

**10. ADJOURNMENT**

There being no further business, the meeting was adjourned at 5:45 p.m.
