# "Don't Just Stand There—Volunteer!" Volunteer Fair Planned for November 15th

Age Friendly Berkshires is teaming up with three area nonprofits and the region's municipalities, to host a **VOLUNTEER FAIR** on Friday, November 15<sup>th</sup>, 2019 from 1:00 p.m. to 3:30 p.m. at Saint James Place, 352 Main Street, Great Barrington. The event is being underwritten by AARP Massachusetts.

"Don't Just Stand There—Volunteer!" is the co-creation of Age Friendly Berkshires, Nonprofit Center of the Berkshires, Berkshire United Way and the Osher Lifelong Learning Institute (OLLI). The event is open to all, but people age 50+ are especially encouraged to attend. Age Friendly Berkshires' coordinator Peg McDonough, explained, "One of Age Friendly Berkshires' goals is to boost the overall health and well-being of our adult population and combat social isolation and loneliness. An easy way to do that is to volunteer for local causes, close to home and heart."

The Volunteer Fair will highlight the good work of over 30 nonprofits and include a 1-stop Civic Station, to learn about openings on municipal Committees, Commissions and Boards, county-wide. Attendees will be given a Volunteer Passport and Skills Checklist—for matching personal talents, interests and values with local volunteer opportunities. There is no fee to attend. Attendees will be encouraged to visit four or more volunteer stations, for the chance to win door prizes.

Many people may discount the risk and not take any precautions, but one of the municipalities in the Berkshires was just hit with ransomware and has lost almost all of their files.


Some things you should do to help reduce your risk of attack include ensuring you have the latest operating system and patches in place, making sure you have an up-to-date virus protection software monitoring your computer, and are actively backing up your files, preferably to an off-site location. But the single biggest thing you can do to prevent cyberattacks is to practice caution when viewing emails and browsing the internet and to not open attachments or follow links that you are not sure about.

If you are a municipality, you may want to explore getting cyber security insurance, having an assessment of your computer network performed, and training your employees on best practices to avoid cyber-attacks.

# **Are You A MVP Community?**



In September 2019 the Executive Office of Energy and Environmental Affairs (EEA) will announce available grant funding for municipalities under the Municipal Vulnerability Preparedness (MVP) grant program. The MVP Program provides support for cities and towns to begin the process of planning for climate change resiliency and implementing priority projects. Please see the map on the left to see your municipality's MVP Status.

If your town is not an MVP Planning Grant Community or Designated Community, your town is eligible to apply for an MVP Planning Grant to complete vulnerability assessments and develop an action-oriented resiliency plan. Towns have no financial commitment under the MVP Planning Grants, but are required to dedicate 120 hours for municipal staff time.

If your town or city is an MVP Designated Community, you are eligible for an MVP Action Grant. Culvert assessments and replacements are eligible for MVP Action grant funding, as well as much larger scale projects such as streambank stabilization or microgrids (max. award \$2M per project). A 25% match is required under the MVP Action Grants.

# **September is Preparedness Month!**

Preparing yourself and your family for disasters is an important thing to do. The Department of Public Health (DPH) and the Massachusetts Emergency Management Agency (MEMA) have partnered for National Preparedness Month to help residents prepare for and respond to natural, technological, and man-made disasters. There are four steps you can take to become more prepared:

Be informed. Pay attention to severe weather watches and warnings. Tune into local news, National Weather Service announcements, and the National Oceanic and Atmospheric Administration (NOAA) weather radio for current information. Sign up for emergency alerts or reverse 911 to get up to date information from emergency authorities in your community. If you don't know how to sign up, or want more information, contact your local Emergency Management Director (EMD). You can find your local EMD here: http /www.mass.gov/find-your-

Make a plan. Work with your family to prepare a communications plan in your home. You can create a shelter-in-place plan, as well as an evacuation plan, to keep yourself and your family safe whether you "stay" or "go". Build an emergency kit. Every home and business should have a basic emergency supply kit for any emergency, at any time of the year. You'll want to include necessities such as bottled water, food, flashlights, a battery-powered radio, and a first aid kit. More information can be found here: https://www.ready.gov/build

Get involved. Disaster preparedness, response, and recovery takes the whole community to be effective. You can support the cause by volunteering for the Berkshire Medical Reserve Corps (MRC) unit, with the Community Emergency Response Team (CERT), or another affiliated program. #### Berkshire Mall Future Use Study

Berkshire Regional Planning Commission recently completed an 18-month reuse study of the Berkshire Mall on behalf of the Town of Lanesborough. Elements of this plan include evaluation of current site, building, utility, and market conditions, research on reuse of mall properties and active developers in other markets, assessment of current zoning and regulations, solicitation of public input, and development of five potential redevelopment scenarios. Engineering and reuse concept development were conducted through Milone & MacBroom, Inc., of Springfield, MA and EDM Architecture, Engineering & Management of Pittsfield, MA. Funding for this project was provided by the MA Executive Office of Energy and Environmental Affairs, and supported with a partial match by the Baker Hill Road District in Lanesborough. # Berkshire Bikesharing on the Horizon?

Transportation planning staff at BRPC would like to thank all those that attended Pittsfield's 3<sup>rd</sup> Thursday event this past July—and specifically to those that were willing to hop-on and try out one of Bewegen's electric pedal-assist bicycles. It was a pleasure to see such warm reactions by those that test rode the e-bikes—as I'm sure anyone who has ridden one for the first time knows—they are an instant smile-generator.

As mentioned in last month's issue, Bewegen is the equipment supplier for the *ValleyBike* Share program operating in Hampden and Hampshire Counties, just east of Berkshire County—in Amherst (including UMass campus), Holyoke, Northampton, South Hadley, Springfield and Easthampton. *ValleyBike* Share continues to see high ridership into its second year of operation. Transportation staff at BRPC are eager to study the potential of a Berkshire bikeshare program operating at the municipal levelùand gradually assess its potential at the county-level. The City of Pittsfield has expressed interest in studying the feasibility of a municipal bikeshare program. Pending final decision-making, the City may apply for technical assistance funding through the Workforce Transportation Program and, if awarded, would provide financial assistance for the City to assess the viability of a Pittsfield-based bikeshare program. This program represents an excellent opportunity for the city and surrounding municipalities to move one step closer to creating the multimodal transportation network Berkshire residents deserve!

# **Hazard and Flood Mitigation Grants Announcement**

The Federal Emergency Management Agency (FEMA) has announced new Pre-Disaster Mitigation (PDM) and Flood Mitigation Assistance (FMA) grants. The Massachusetts Emergency Management Agency (MEMA) will be calling for applications from municipalities that need funding for new or updated Hazard Mitigation Plans, project scoping, and flood or other hazard mitigation projects for towns/cities with current Hazard Mitigations Plans. Applications to be submitted by January 31 st, 2020.

#### **Lenox Cultural District Established**

The Massachusetts Cultural Council (MCC) recently designated downtown Lenox as a Cultural District, after a year-long application process assisted by Berkshire Regional Planning Commission. Lenox is the 46<sup>th</sup> Cultural District in Massachusetts, and the 5<sup>th</sup> to be established in Berkshire County, joining Downtown Great Barrington, North Adams, Upstreet (Pittsfield), and Williamstown Cultural Districts. Cultural Districts are walkable, compact areas with a density of cultural, artistic, and economic activity. Launched in 2011 by an act of the state legislature, the Cultural District program "drives economic growth, strengthens our distinctive local character, and improves the quality of life for families across Massachusetts." Districts are established with the goals of attracting artists and cultural enterprises, encouraging business and job development, positioning the district as a tourist destination, preserving and reusing historic buildings, enhancing property values, and fostering local cultural development.

Districts are established and renewed on a five-year cycle, and are overseen by steering committees populated with municipal, higher education, and for- and non-profit representatives from the host community.

# MassDOT East-West Passenger Rail Study

The Massachusetts Department of Transportation (MassDOT) is conducting a study to examine the costs, benefits, and investments necessary to implement passenger rail service from Boston to Springfield and Pittsfield, with the speed, frequency, and reliability necessary to be a competitive option for travel along this corridor. The study will assess up to six alternatives, which will feature a range of approaches including high speed rail and potential infill stations. BRPC has developed a survey to assess potential ridership demand, preferred travel times and costs, and to understand how Berkshire County residents might utilize such a connection.
