

2. Review of minutes of January 11, 2019 meeting. Motion to accept the minutes, as amended was made by R. Wood, seconded by C. Gibson and unanimously approved.

3. Executive Session – for legal strategy and mediation. N. Karns requested a motion to go into Executive Session for mediation regarding the EPA Rest of River clean-up and the appeals of the EPA's Permit and the EAB decision. Such discussion, if held in open meeting, may have a detrimental effect on the legal position of the Rest of River Municipalities' legal action with EPA and GE.
