 Introductions. N. Karns opened the meeting at 12:04 pm. Committee members attending: Pat Carlino, Lee Select Board and Representative Channing Gibson, Lenox Representative Chris Rembold, Great Barrington Representative Steve Shatz, Stockbridge Representative Rene Wood, Sheffield Select Board and Representative

2. Review of minutes of November 15, 2019 meeting. A motion was made to accept minutes of 11-15-19 by R. Wood and seconded by P. Carlino; minutes approved as written: R. Wood, Sheffield, AYE; P. Carlino, Lee, AYE; C. Rembold, Great Barrington, AYE; S. Shatz, Stockbridge, AYE; and C. Gibson, Lenox, AYE.

3. Executive Session – for legal strategy, mediation and meeting/conferring with mediator. N. Karns requested a motion to go into Executive Session with respect to litigation or decision of public business whereas if the discussion where held in open session it may be detrimental to the legal position of the Rest of River Municipal Committee legal action with EPA and GE. *A motion made by R. Wood and seconded by C. Gibson, for the Committee to enter into Executive Session, as stated above and to return to open session, carried with the following roll call vote: R. Wood, Sheffield, AYE; C. Gibson, Lenox, AYE; P. Carlino, Lee, AYE; C. Rembold, Great Barrington, AYE; and S. Shatz, Stockbridge, AYE. The Committee went into Executive Session at 12:05 pm.*

At 3:41 the Committee returned to open session. The current IGA expires on December 5, 2019. The Committee is not likely to meet prior to this date; discussion ensued on how best to deal with expiration while the settlement, escrow agreement and distribution of funds is still unresolved.

On a motion by R. Wood and seconded by S. Shatz, with the following roll call vote, the Committee approved extending the current Intergovernmental Agreement as written for a period of one year, to expire December 5, 2020: Chris Rembold, Great Barrington, AYE; R. Wood, Sheffield, AYE; P. Carlino, Lee, AYE; S. Shatz, Stockbridge, AYE; and C. Gibson, Lenox, AYE.

4. Adjournment. At 3:43 pm a motion was made by R. Wood and seconded by P. Carlino, for the Committee to re-enter Executive Session, for reasons stated earlier; the Committee will not return to open session; the motion carried with the following roll call vote: Chris Rembold, Great Barrington, AYE; R. Wood, Sheffield, AYE; P. Carlino, Lee, AYE; S. Shatz, Stockbridge, AYE; and C. Gibson, Lenox, AYE.
