Outdoor Dining Post-COVID

Berkshire Regional Planning Commission uses the firm of Miyares and Harrington, LLP as its legal counsel. In Miyares Harrington's recent newsletter, there was an excellent article about outdoor dining for restaurants when the COVID-19 crisis has ended. In the midst of the pandemic, Governor Baker issued COVID-19 Order No. 35, § 4, on June 1, 2020 which "gave

municipalities authority to approve restaurants' requests for expansion of outdoor table service, including expansion of the licensed premises, without going through the usual statutory permitting process."[1] A subsequent order extended this until 60 days past the end of the state of emergency, at which time restaurants must return to their pre-COVID seating policies. On May 25, 2021 Governor Baker filed legislation to extend the provisions through November 29, 2021.

Increased outdoor seating has created new opportunities for both restaurants and their patrons alike. Many restaurants will seek ways to continue the extended outdoor seating options in the wake of the pandemic, but would have to do so under the normal permitting process. This will likely lead to questions and concerns over the existing policy. If outdoor seating during the pandemic has been largely successful, why return to normal? Municipalities should be prepared for these discussions and may seek to review and amend local regulations. Additionally, towns and cities should continue to pursue new, creative seating arrangements to bolster local business and provide more options for businesses and their customers.

Berkshire County Open Burn Permits

Berkshire County completed another successful year of the Berkshire County Open Burning Permits program. The participating communities issued 11,367 permits for burning from January 15, 2021, through May 1, 2021. The program added six communities this year, which brings the total to 23 Berkshire communities and two from other counties. The communities that participated for the last two years saw a decline of almost 14% in the number of permits, likely due to the drought and high fire risk, which resulted in numerous days of fires not being allowed. Green Communities Regional Energy Planning Assistance Funding Opportunity

BRPC is applying for funding under the Massachusetts Department of Energy Resources (DOER) Green Communities program for Regional Energy Planning Assistance (REPA) to provide technical assistance to municipalities. BRPC will be submitting applications for funding on behalf of communities that have received Green Community designations and want to engage in clean energy planning activities and those that want to become designated. To be eligible BRPC must receive a signed MOU from the community **no later than June 11, 2021.** Contract duration is 2 years long and begins September 10, 2021.

The Regional Energy Planning Assistance (REPA) program seeks to: 1) augment municipal resources necessary to effectively participate in the Green Communities Designation and Grant Program; and 2) build local capacity to advance local or regional municipal and clean energy projects and programs.

Reduce Nonpoint Pollution through Sustainable Landscaping

Summer is here! With gardens in bloom and lawns growing, it is a good time to remind residents to practice sustainable landscaping. Fertilizers, pesticides, pet waste, grass clippings, and other yard waste can wash off into public storm sewer systems that lead to our waterways. This nonpoint source pollutant of nutrients, bacteria, and chemicals can lead to poor water quality, disrupted aquatic life and fish populations, harmful algal blooms, and public health risks in our county's streams, lakes, rivers, and ponds. Getting soil tested to determine proper fertilizer needs, encouraging residents to reduce chemical use, and properly dispose of pet and yard waste goes a long way to maintaining clean water. *If your town is renewing pet licenses this month, consider providing a flyer about proper pet waste disposal along with renewals*.

Residents and town officials can find more information on the <u>Think Blue Massachusetts</u> website. **Outreach is a requirement for municipalities with MS4 areas**, but good practice for all. HIV/Bloodborne Pathogen Outbreak Table Top Exercise and Emergency Response Plan

BRPC Public Health Program staff held a Workshop and Table Top Exercise (TTX) May21st to test the draft Berkshire County HIV/Bloodborne Pathogen Emergency Response Plan. The workshop received funding from the Health Resources Service Administration (HRSA) Ryan White HIV/AIDs program.

Staff have been working with community partners since 2019 to develop a comprehensive community response plan to address possible outbreaks of HIV and other bloodborne pathogens. The primary partners on this planning and exercise effort were Sarah DeJesus from Healthy Steps, Katrina Mattson from Tapestry Health, Lieutenant Stephen Murray from Northern Berkshire EMS, and Jess Tilley from H4H 413.

The planning effort was led by BRPC Senior Planner Sandra Martin, community and harm reduction engagement by Principal Planner Jennifer Kimball. The Table Top Exercise was facilitated by Senior Planner Allison Egan.

The purpose of the plan is to address gaps in public health emergency planning in Berkshire County. There are robust plans for sheltering, Emergency Dispensing Site (EDS), pandemic response and vaccination programs (bolstered by the lived experience of the COVID-19 pandemic). But there are no plans that address an HIV or other bloodborne pathogen outbreak among People Who Use Drugs (PWUD). There have been outbreaks of HIV in rural counties and communities that have very similar statistics to Berkshire County. The Centers for Disease Control (CDC) have classified Berkshire County as "high risk" for an HIV outbreak.

Table Top Exercises are used in traditional emergency response planning to test specific capabilities of response plans. Facilitators create an immersive, simulated and realistic scenario that community partners work through together in a "workshopping" format. The exercise scenario reflected a realistic circumstance in which HIV is spreading across Berkshire County, primarily among PWUD. Through this realistic scenario, community partners and people with lived experience worked together to troubleshoot techniques to reduce the spread of HIV and conduct a widespread testing and treatment program for the community. Partners included: Harm Reductionists, Direct Service Providers, the Berkshire County Sheriff's Office, EMS, Public Health Nurses and BRPC Planners.

In Massachusetts, roughly 9,000 new Hepatitis C (HCV) cases are diagnosed each year. Though largely impacting the so-called "Baby Boomer" generation, new HCV infections related to injection drug use have been steadily increasing. At the same time, this increase has been paralleled by the re-emerging risk of HIV co-infection in these same populations.

The Massachusetts Department of Public Health, New England Aids Education and Training Center (NEAETC), and the Berkshire Opioid Addiction Prevention Collaborative (BOAPC), a public health program within BRPC, are working to develop new and innovative partnerships to better understand drug use and HCV/HIV infection trends and the needs and gaps of impacted populations in Berkshire County.

This collaboration builds on existing state programs, funding streams, coalitions and clinical networks. The goal is to implement responsive strategies to increase access to the HCV/HIV care continuum (such as increased referrals to clinical HCV services at Berkshire Health Systems Healthy Steps program).

One of this project's multiple interventions is the re-launch of the Berkshire County Hepatitis C Working Group. The intention is to become a Berkshire County-focused HCV Community of Practice (CoP). Communities of Practice are a way for groups to develop and share knowledge, providing a safe environment for sharing and solving complex clinical issues, supporting collaboration, and promoting evidence-based best practice.

Building upon the statewide HCV Community of Practice, the Berkshire County CoP will meet the first Wednesday of the month (except for quarterly meetings of the statewide CoP). CoP members are primarily clinicians but include community health workers, public health practitioners, and harm reductionists. Coronavirus Local Fiscal Recovery Fund (CLFRF) Eligible Uses

On March 11, 2021, the President of the United States signed into law the American Rescue Plan Act of 2021 (ARPA). This law provides resources through the new Coronavirus Local Fiscal Recovery Fund (CLFRF) to local governments to respond to the public health emergency caused by the Coronavirus Disease (COVID-19). This fund is administered by the US Department of the Treasury. On June 3, 2021, the Massachusetts Executive Office for Administration & Finance Federal Funds Office posted a memorandum regarding Coronavirus Local Fiscal Recovery Fund (CLFRF) eligible uses. Transportation

Unified Planning Work Program Released for Comment

The Unified Planning Work Program (UPWP) for FFY 2022 has been released for public comment by the Berkshire Metropolitan Planning Organization (MPO). The UPWP outlines the work activities of transportation planning staff for the up coming federal fiscal year. Some of the areas that will receive attention include updating the Public Participation Plan to accommodate virtual public involvement, engaging towns to increase their knowledge of and participation in the TIP process, working to identify an alignment for the Berkshire Bike Path from Adams to North Adams and furthering design efforts for the Adventure Trail from Williamstown to MASS MoCA.

Other items that staff will focus on are the Transportation and Climate Initiative promoting electric vehicles and charging infrastructure, implementation of a Transportation Management Association and involvement with rail service implementation efforts.
