The Massachusetts Department of Environmental Protection (MassDEP) announces funding for private, public, and non-profit entities to replace eligible diesel vehicles and equipment with zero emission technologies. Through the federal **Diesel Emissions Reduction Act** (DERA) program, Massachusetts is conducting a competitive electric-only Solicitation with an application deadline of **5 PM August 24, 2022**. New Guidance on Solar Energy Zoning Bylaws / Ordinances

The Supreme Judicial Court case, Tracer Lane II Realty v. City of Waltham, provided new guidance on a municipality's ability to regulate solar energy facilities. In this case, the proposed solar energy facility was to be located in the Town of Lexington, but accessed solely by a proposed road across a residentially zoned parcel in the adjacent City of Waltham. Waltham refused development of the access road on the basis that it was a commercial use prohibited in the residential zone. The Supreme Judicial Court concluded that Waltham's zoning bylaw—which prohibited large-scale solar facilities in all but one to two percent of its land area—presented an unreasonable regulation of solar energy systems. Section 3 of The Zoning Act, states, "No zoning ordinance or by-law shall prohibit or unreasonably regulate the installation of solar energy systems or the building of structures that facilitate the collection of solar energy, except where necessary to protect the public health, safety or welfare." In this case, however, The Court focused on the stringency of Waltham's prohibition, finding that there was no reasonable basis grounded in "public health, safety, or welfare" to restrict solar energy systems to such a small portion of the City's land area. The Court also noted that such a restriction "restricts rather than promotes the legislative goal of promoting solar energy."

Communities considering solar energy bylaws should conduct a planning process that includes "public health, safety, or welfare" risks to identify locations where such solar energy systems would present risks to the public interest. Reasonable restriction likely could be placed on those systems in a manner proportional to that risk. So Much Happening in Stormwater

BRPC hired two incredible interns to map the stormwater systems in MS4 communities and look for potential pollution making its way through stormwater pipes and into our lakes and rivers. If you see them out in the field, be sure to say hello and tell them if you've noticed any stormwater issues. We're also looking at town bylaws & zoning requirements to see how friendly regulations are to green infrastructure and make recommendations on how to encourage stormwater infiltration through local policy. Finally, we joined the University of New Hampshire's Stormwater Center on green infrastructure site assessments as part of an Upper Housatonic Mass DEP nutrient and bacteria study. It was amazing to see all the opportunities and have some quality time outdoors!

Northern Tier Rail Study Public Meeting

The study team will share an overview of the study's background, review the existing conditions analysis, and garner feedback on issues and opportunities along the corridor. A great deal of work has occurred on this study and this is an opportunity to learn about the study's progress.



Safe Streets and Roads for All

An opportunity to make important capital investments in the safety of roadways around Berkshire County is available. The Safe Streets and Roads for All (SS4A) grant program is a new component of the federal Infrastructure Investment and Jobs Act, also known as the Bipartisan Infrastructure Law or BIL. Over the past decade, we have begun to reverse the significant safety progress made over the past half-century. 2021 is projected to be the deadliest year on our roads in the past sixteen years. Berkshire County's 5-year average rates of death and serious injury have been increasing as well.

Who can apply for the grant? Local entities including town, city, village, and county governments, as well as metropolitan planning organizations (MPOs), federally recognized Indian Tribal governments, or multi-jurisdictional collaborations between the preceding entities may apply for SS4A grants. State government agencies and Departments of Transportation (DOT) are not eligible to apply for these funds, although it is encouraged to coordinate and gain support from these bodies.

How does the grant process work? The SS4A grants are split into two categories: Action Plan and Implementation.


- Action Plan grants are for the development of a Comprehensive Safety Action Plan (CSAP).
- Implementation grants are reserved for projects identified in a CSAP. A CSAP must be completed and approved by USDOT before applying for Implementation funds.

Award Levels:

- Action Plan grants: \$200,000 to \$1 million, with MPOs eligible for up to \$5 million.
- Implementation grants: \$3 million to \$30 million, with MPOs eligible for up to \$50 million.

Local match required: 20% Deadline: September 15
