## **Grants & Opportunities & Meeting Dates**

The Massachusetts Department of Environmental Protection (MassDEP) announces funding for private, public, and non-profit entities to replace eligible diesel vehicles and equipment with zero emission technologies. Through the federal **Diesel Emissions Reduction Act** (DERA) program, Massachusetts is conducting a competitive electric-only Solicitation with an application deadline of **5 pm August 24**, **2022**. This is an early replacement program designed to accelerate the retirement of less efficient and more polluting diesel vehicles and equipment. Website for more information and to apply **HERE**.

## **Environmental & Energy**

### **604b Grant Opportunity**

Massachusetts Dept. of Environmental Protection has released a Request for Responses for the 2022 Clean Water Act Section 604b Grant Cycle. This is a *no match required* grant opportunity for municipalities to address stormwater pollution. Grant funds can cover the cost of water quality pollution studies, conceptual engineering designs for stormwater infrastructure, watershed-based plans, and more. ### Level 1 Mild Drought in the Berkshires

Due to 2 months of below normal rainfall, a mild, level 1 drought has been declared for Berkshire County. Mild drought is not completely unusual however, we should still be aware of how we can help mitigate our water use and alleviate strain on our water systems. While it's hard to attribute any one weather event to climate change, this is in line with climate predictions for Western Massachusetts. Droughts are expected to become more frequent while our rain events are expected to come on stronger, with more rain in each storm.

If you are a heavily forested community with dry tinder, take care to watch for wildfires, and advise outdoor recreation to be fire conscious. To help conserve water, we encourage everyone to limit watering outside to once a week between the hours of 5 pm and 9 am, check emergency connections, limit new landscaping and outdoor washing, and encourage residents to use lowflow, water-conserving appliances or techniques both indoors and out. If you haven't already done so, consider developing a local drought plan for your water supply, and stay cool!

#### Residents and Businesses:

• Toilets, faucets, and showers are more than 60% of indoor use. Make sure yours are **WaterSense** efficient.

#### Immediate Steps for Communities:

- Adopt and implement the state's nonessential outdoor water use restrictions for drought.
- Limit or prohibit installation of new sod, seeding, and/or landscaping; watering during or within 48 hours after measurable rainfall; washing of hard surfaces (sidewalks, patios, driveways, siding); personal vehicle or boat washing; filling of swimming pools.
- Establish water-use reduction targets for all water users and identify top water users, and conduct targeted outreach to help curb their use.

#### Short- and Medium-Term Steps for Communities:

• Establish a year-round water conservation program that includes public education and

communication.

- Provide timely information to local residents and businesses.
- Implement or establish drought surcharge or seasonal water rates.
- Check emergency inter-connections for water supply.
- Develop a local drought management plan using guidance outlined in the state <u>Drought</u> <u>Management Plan</u>.

### Berkshire Flyer Pilot Running Smoothly

The <u>Berkshire Flyer</u> pilot, a weekend train service connecting New York City and the Berkshires launched on July 8 with a successful inaugural run that will continue through September 5, 2022. The pilot train departs from New York Penn Station at 3:16 pm on Fridays and arrives at Joseph Scelsi Intermodal Transportation Center in Pittsfield at 7:12 pm. Departure from Pittsfield is at 3:00 p.m. on Sunday and arrival in New York City is 7:05 p.m. The Berkshire Flyer is a two-year pilot service running for the summers of 2022 and 2023 to test the demand for this route. In 2023 the pilot service will run from Memorial Day weekend in May to the Indigenous People's / Columbus Day weekend in October.

Berkshire Flyer is vital for the economic development of Berkshire County. After 51 years, Berkshire County has been connected directly with New York City via train. This train service improves transportation connections and is a gateway for Berkshire County's future growth.

The first three weeks of the trains have been sold out. The riders' surveys show that they are here for various purposes: to attend art & cultural events and to enjoy the natural beauty and adventures that Berkshire County has in abundance. The Berkshire Flyer riders are of all age groups, from millennials to older adults, some new and some visiting again as it is convenient to ride the Berkshire Flyer train. The Berkshires has it all for everyone; an oasis of natural beauty, art, and culture; a perfect weekend getaway for New York City residents!

The Berkshire Flyer also improves transportation connections for Berkshire residents. It provides a train connection between Pittsfield, Albany/Rensselaer, and other NY destinations. Book your ticket, hop on the Berkshire Flyer train, relax, and enjoy the scenic view along the trip!
