The Expression of Interest period continues through March 17, 2023. Last year, 75% of successful applicants statewide participated in and received feedback through the Expression of Interest process. Full Applications are also now OPEN. Applicants may log into the IGX system to begin working on full applications online. MassDEP has formed a **Deconstruction Workgroup** to explore the feasibility of bringing deconstruction to Massachusetts. Rather than quick demolition by machine with all materials going into a landfill, deconstruction mandates that a building slated for demolition be disassembled with materials reused where possible. The previous two Deconstruction Workgroup meetings can be viewed here. While there is a core planning team of MassDEP and colleagues, the Workgroup meetings are open to anyone interested in the topic.

Community

Windsor Completes Master Plan

The Town of Windsor completed its <u>Master Plan</u> after a year-long process that involved interviewing town stakeholders, surveying the town's populace, and then developing and drafting the document that directs town activities for the coming 10-20 years. The Planning Board appointed a steering committee composed of individuals across the spectrum of town boards, including the Parks and Recreation Committee, Select Board, Finance Committee, Green Committee, Finance Committee, Police and Fire Department, and Zoning Board of Appeals. The project was funded by a Community Planning Grant from the Commonwealth of Massachusetts through Berkshire Regional Planning Commission. Community feedback from the 22-question survey completed by 19.5% of the town's eligible population provided the committee with a host of actionable items that then led to the development of an implementation plan.

The document provides a brief description of the town's population characteristics and defines the existing services and facilities in the town. Available housing, land use, and open space are addressed in the plan and were important aspects of why Windsor residents choose to live in the community. Many residents also referred to the low tax rate and natural amenities right in their backyards as reasons to live in Windsor. Another reason that individuals are attracted to Windsor is the newly installed Broadband network overseen by the town's Municipal Light Plant Board. The ability to connect to reliable and fast internet services is increasingly viewed as a necessary utility, especially with remote working opportunities, making Windsor a more viable location to live and work.

In planning for the future, the plan addresses issues such as the availability of developable land and how that impacts available services, housing affordability and short-term rentals, assessing senior and community center needs, and attracting volunteers to participate in town governance and capacity. With the adoption of a Master Plan, the town has charted a course for the near term and enabled a greater variety of state funding for town programs.

Data & Information Services

Race and Ethnicity

The U.S. Office of Management and Budget's (OMB) Office of the Chief Statistician released preliminary recommended revisions to Race and Ethnicity standards. These standards define how the U.S. Government collects and reports race and ethnicity. This review is the first step to updating the 1997 standard the federal government currently uses. The proposed update was undertaken to ensure that the standards better reflect the racial and ethnic diversity of the U.S. population. The initial proposal calls for collecting race and ethnicity with a single question, adding a response category for Middle Eastern and North African, and updating terminology, definitions, and question wording. Information on the proposed changes is available online.

Mass Municipal Data Hub

The MMA has launched a new, online Data Hub created as a digital replacement for the annual Massachusetts Municipal Directory. The Data Hub provides a wealth of information about each city and town, plus the ability to compare communities based on anything from forms of government, population, road miles, tax rates, or school enrollment, to total expenditures, and much more. The data spreadsheet seamlessly blends information from a number of trusted sources.

Economic Development

The Shared Economic Development Planner program allows each participating town to access services that fit its specific needs and budget. Communities receive assistance with creating a welcoming environment for businesses and residents through a range of tactics, as well as support in developing economic development-related grant applications or collaborations with neighboring towns. Massachusetts Broadband Institute Municipal Digital Equity Planning Program

BRPC is a pre-qualified consultant to provide services to municipalities participating in MBI's Municipal Digital Equity Planning Program. The program is appropriate for last-mile towns that have high-speed broadband to most residences and towns that do not yet have this service.

Environmental & Energy

Best Practices to Reduce Salt in Water Supply

This winter has given us a few snowstorms to contend with, and salt, aka chloride, has been one of our most readily used tools to manage road safety. Salting roads no doubt keep our roadways

ice-free and safer, but it comes at a cost to surface water and groundwater quality. Chloride is one of the few common pollutants that isn't easily treated through green infrastructure control measures. Instead, chloride is most effectively reduced during application. In other words, to reduce groundwater contamination from chloride, it's important to use best practices to reduce the need for its application in the first place.

New Hampshire is leading this effort by training plow contractors through the <u>Green SnowPro Certification program</u> on technologies and winter maintenance practices that reduce the need for salt. An online training of this program called <u>Smart About Salt</u> is available through July 31, 2023. Another great resource is the Clear Roads initiative which funds research into winter maintenance impacts and best practices. Clear Roads has recently published its <u>Annual Survey of State Winter Maintenance Data</u>, which compiles data on winter resources, materials, and costs from 36 states for the 2021-2022 winter season.

Public Health

Six months into the <u>HEALing Communities Study</u>, Berkshire County community members have met in Coalition and subcommittee meetings to develop strategies on overdose education and Narcan distribution as part of a nationwide effort to reduce opioid overdose deaths. Narcan, aka naloxone, is a nasal spray used to reverse an opioid overdose immediately and is completely safe to administer to people experiencing a suspected opioid overdose.

As part of these efforts, BRPC's Berkshire Overdose Addiction Prevention Collaborative, or **BOAPC**, will assist with larger communications campaigns about



reducing the stigma around carrying Narcan and making it as normal as a fire extinguisher or first aid kit. These efforts include the "Faces of Narcan" campaign with community members' faces on billboards and Berkshire Eagle ads sponsored and paid for by the Healing Communities grant.

In addition, efforts will promote BOAPC's <u>"Find Naloxone"</u> page, containing a map of locations to access Narcan. The map will be updated as more locations become available. In the future, these locations will have overdose rescue kits or NaloxBoxes, containers housing Narcan, instructions on how to use them, and signs of an overdose. BRPC Public Health staff will coordinate these efforts throughout the year. BRPC/BOAPC will eventually provide naloxone through the mail for those unable to access it elsewhere. Transportation

Governor Baker Signed New Law to Reduce Traffic Fatalities

A traffic safety bill under consideration in legislative sessions since 2011 was signed into law on the last day of Governor Charlie Baker's administration. Among other provisions, the new law enacts several new regulations:

- 1. **4-foot passing law:** When a motor vehicle or truck driver desires to overtake a vulnerable road user (someone walking, cycling, using a scooter, wheelchair, or other low-powered mobility devices), the driver must move aside to there are at least four feet of separation between the side of the vehicle and the vulnerable user. Crossing the centerline of the road is permitted when determined safe to do so.
- 2. **Truck safety enhancements:** Any trucks or trailers purchased by the Commonwealth must be equipped with side-guard panels or skirts, additional mirrors, and backup cameras.
- 3. **Speed limit modifications:** Local jurisdictions may petition MassDOT to lower speed limits on state-jurisdictional roads. MassDOT has 90 days to respond to the request and, upon approval, will install new speed limit signage in the targeted areas.

This Act joins the transportation bond bill passed by the state legislature in the summer of 2022, which legally classified electric bicycles as either Class I or II in the Massachusetts General Laws for the first time. Classes are based on the level of assisting power provided by the electric motor and whether the bike has a throttle control. This allows for more nuance when regulating their operation in certain areas, like multi-use paths. Together, these new acts represent important

steps in making the roads of the Commonwealth safer for all users.

BRPC Awarded Comprehensive Safety Action Plan Grant

The Berkshire Regional Planning Commission's Transportation Team is pleased to announce that they have been selected for funding in the nationally competitive <u>Safe Streets and Roads for All</u> (SS4A) grant program. This funding is provided through the US Department of Transportation (USDOT), as authorized by the Bipartisan Infrastructure Law (BIL). Approximately \$1 billion is authorized each year for the next five years to fund the SS4A program. It

consists of two parts: Action Plan Grants and Implementation Grants. BRPC has been awarded Action Plan Grant funding. Completing an Action Plan opens the door for the opportunity to receive Implementation Grants in future years. Along with support from the MassDOT Office of Transportation Planning (OTP), the budget for BRPC's Action Plan initiative is \$248,231.

Berkshire County joins 509 other awardees from around the United States who will be working to bring the number of fatalities and serious injuries on our roads down to zero in the future. In January of 2022, the USDOT released its **National Roadway Safety Strategy (NRSS)**, a new direction in the fight to turn the tide of rising road fatalities and injuries during this past decade. The SS4A is providing funding to Metropolitan Planning Organizations (MPOs), cities, towns, and tribal governments to begin tackling the initiatives posed in the *NRSS*. The five overarching initiatives spelled out in the *NRSS* are: safer people, safer roads, safer speeds, safer vehicles, and better post-crash care.

The Berkshires' Action Plan process intends to study the local implications of each of the five NRSS safety initiatives and what systemic and infrastructural changes could be proposed to achieve gains in each. The process will kick off with convening of a steering committee composed of elected and non-elected stakeholders from throughout the region, including town administrators, highway crews, first responders, planners, engineers, and advocacy organizations. From there, measurable goals and data points for the five NRSS safety initiatives will be decided upon, and data will be gathered in a comprehensive way to help the committee discern where the most appropriate and cost-effective safety interventions could be proposed. A final report will indicate desired projects and programs for future implementation. The report will open the door for future funding opportunities to implement safety enhancement projects in Berkshire County.
