Fiscal Year 2023 BRIC and Flood Mitigation Funding Opportunities

FEMA published the fiscal year 2023 funding opportunities for the <u>Building Resilient</u> <u>Infrastructure and Communities</u> for \$1 billion and the <u>Flood Mitigation Assistance</u> grant program for \$800,000 million. These funds will help state, local, tribal and territorial governments address high-level future risks to natural disasters, foster greater community resilience and reduce disaster suffering.

District Local Technical Assistance 2024

Berkshire Regional Planning Commission is soliciting eligible projects from its member communities to receive technical assistance under the 2024 District Local Technical Assistance (DLTA) program. Under this program, BRPC staff provides technical assistance to communities, at no cost to the community, on eligible projects. Projects must fall into one of the two general priority categories to be considered eligible for technical assistance:

- 1. "Planning Ahead for Housing" (or to help reach the Statewide Housing Production Goal) or "Planning Ahead for Growth"; and
- 2. Community Compact Cabinet Activities

Applicants must be municipalities and applications must be signed by the Chief elected official. Applications must be emailed and are due no later than **January 26**, **2024**. Information and application material is on the Berkshire Regional Planning Commission website under **Solicitations**. A fillable version of the application is also provided to facilitate the application

- The Broadband Equity, Access, and Deployment (BEAD) Initial Proposal

Documentary Premiere Blueprint: Building the Foundation for Recovery

As many of you know, we're nearing the end of the HEALing Communities Study on 12/31/2023. This has been a large project for many at BRPC and our community partners. As the culmination of the study, we will premiere Blueprint: Building the Foundation for Recovery, a documentary featuring real stories of recovery in the Berkshires. The film will be followed by a conversation on how we can heal our community together. You can choose Wednesday, December 13, 7:00 pm at the Massachusetts College of Liberal Arts Church Street Center in North Adams, Thursday, December 14, 7:00 pm at the Colonial Theatre in Pittsfield, or both! Register HERE.

Over the past 18 months, local partners from the harm reduction, treatment, and recovery communities have collaborated on a shared goal of reducing opioid overdoses. Partners from across the Berkshires joined together to increase naloxone distribution, raise awareness of all pathways to treatment and recovery, and reduce stigma around substance use disorder.



Blueprint is a new documentary from Outpost Studios weaving together stories from our community with local behavioral health experts. Filmmakers George Cox and iin Purwanti have interviewed over a dozen community members for the feature, with original music by local artist Matt Cusson.

The premiere will be followed by a community conversation with a pane of local experts, including Dr. Jennifer Michaels form The Brien Center, Sarah DeJesus from BHS's Berkshire Harm Reduction, Gabriela Leon from BHS's Berkshire Connections, Steffon Ashley from the Crane Center's Black Voices in Recovery, and Ariel Killackey from Living in Recovery.

No matter who we are or where we come from, we all know someone who has been impacted by addiction. This film and conversation will explore what's been accomplished to date, what work needs to continue, what can be built up, and most importantly, what you as a community member an do to help reduce overdoses and stigma.

Berkshire Flyer 2023 Pilot

The Berkshire Flyer had a successful second pilot year this summer; over 1,271 passenger trips occurred over a twenty-week season. The Flyer is a weekend service operated on Fridays and Sundays between New York Penn Station and the Pittsfield station via Albany/Rensselaer. The 2023 pilot service ran from Memorial Day weekend through Columbus Day/Indigenous Peoples' Day weekend.

The ridership patterns were the same in 2023 as in 2022 - dominated by trips between New York

City and Pittsfield, with less than 10% of riders to/from Albany or other stations. July and August saw the highest ridership in the twenty weeks of service.

The riders' survey shows they are here for various purposes: to attend art and cultural events, visit families, and enjoy the natural beauty and adventures in Berkshire County. The Berkshire Flyer riders are of all age groups, from millennials to older adults, some new and some visiting again, as riding the Berkshire Flyer train is convenient.

The 2022 and 2023 Berkshire Flyer pilot services have shown high demand during the summer months. Recognizing the demand for train connection between New York City and the Berkshires, MassDOT is working with Amtrak and CSX to continue the Berkshire Flyer summer weekend service in 2024. The 2024 service will run from Friday, June 21 to Monday, September 2 (Labor Day).

Berkshire Flyer service creates another opportunity to bring visitors to the region and increase tourism. Berkshire County businesses will benefit from continued Berkshire Flyer service in 2024. It improves transportation connections for Berkshire residents by providing a train connection between Pittsfield, Albany/Rensselaer, and other New York destinations.
