#### Round 30 of the Massachusetts Preservation Projects Fund (MPPF) Grant Program

The MPPF is a state-funded 50% reimbursable matching grant program to support the preservation of properties, landscapes, and sites (cultural resources) listed in the State Register of Historic Places. Applicants must be a municipality or nonprofit organization. It is anticipated that funding for Round 30 will be in the range of \$1,000,000. #### **Data & Information Services**

#### 2018-2022 American Community Survey

The US Census Bureau released the 2018-2022 American Community Survey (ACS) data in early December. The ACS is the primary source for most of the demographic data that BRPC uses and can be accessed online at <a href="https://data.census.gov/">https://data.census.gov/</a>. Some highlights for Berkshire County include:

- Median Household Income is \$69,744, an increase of over \$6,500 over the last year.
- Self-employed individuals comprise 12.8% of the county's workforce, an all-time high.
- The percentage of owners and renters who spend 30% or more of their income on housing has decreased slightly, dropping below 50% for renters and 25% for owners.
- The homeownership rate has also reached an all-time high of over 70% of all households owning a home.

BRPC launches new outdoor recreation website, www.berkshiresoutside.org

The new site, coordinated by Berkshire Regional Planning Commission (BRPC) and built by Gemini Creative of Stockbridge, contains a clearinghouse of trailheads, boat launches, and other access points, and users can narrow their search by activity type or with filters for whether the location is dog-friendly, family-friendly, or has restroom or picnic facilities. The website is a major step toward realizing key goals of the <a href="2020 Outdoor Recreation Plan for Berkshire County">2020 Outdoor Recreation Plan for Berkshire County</a>, created by BRPC in partnership with Mill Town Foundation.

This online portal to all things outdoors invites residents and visitors to discover over 400 parks owned and managed by nearly 100 different organizations, all within Berkshire County. The site will serve as a companion to <u>Berkshires.org</u>, the region's official tourism website operated by 1Berkshire. BRPC created the site with input from stakeholders, including 1Berkshire, Berkshire Natural Resources Council and the MA Dept. of Conservation and Recreation (DCR).



#### Economic Development Advocacy Day 2023

BRPC Assistant Director and Economic Development Program Manager Laura Brennan joined a small Berkshire County contingent at the MA Statehouse recently to advocate for the economic development priorities of our region. The group met with several joint committee chairs as well as Anne Gobi, Director of Rural Affairs for the Healey-Driscoll Administration. #### **Public Health**

#### Addressing the Social Determinants of Health in Extreme Heat Events

The Berkshire Regional Planning Commission (BRPC) Public Health Program has received a \$30,000 grant from the <u>New England Rural Health Association</u> (NERHA) to examine and implement strategies and best practices for rural communities with Extreme Heat Events and Emergencies.

Until recently, days with extreme heat were of limited concern to the Northeast Region of the United States. This, combined with our aging population, older housing stock, and relatively infrequent encounters with extreme heat, has left us vulnerable to extreme heat emergencies. Utilizing community stakeholder and emergency responder input, we aim to research and develop response plans and other mitigation strategies that consider the unique challenges of our vulnerable and marginalized community members.

There are a variety of additional strategies that will be researched and considered, which may include things such as:

- Developing and/or supporting a sustainable information system to ensure community members have access to emergency information and resources.
- · Exploring organizational and individual engagement in personal preparedness planning and education.
- · Researching best practices for rural areas in improving access to air conditioning.
- · Research grant opportunities for weatherization of private residences to mitigate against the impacts of extreme heat.

With these strategies, we aim to create a more resilient Berkshire community against the impacts of climate change and the increasing regularity of extreme heat. For additional information on this project, please reach out to Senior Public Health Planner <u>Matthew Bryan</u>.



Senior Public Health Planner <u>Jaymie Zapata</u> was at the <u>Public Health Institute of Western MA</u> (PHIWM) in Springfield to meet Representative Michael Finn, Senator Adam Gomez, and other state Representatives and Senators, who presented PHIWM with \$200,000 in state funding they secured for 413Cares in the FY2024 state budget. <u>413Cares</u> is a new interactive online resource directory for the four Western MA counties that BRPC is helping to adequately reach and represent Berkshire residents and community-based organizations.

#### **Transportation**

#### 2025-2029 Transportation Improvement Program Under Construction

Work on the next Transportation Improvement Program (TIP) has been initiated. The TIP is a document that outlines the transportation projects that will move forward over the next 5 years. This is an opportunity for towns to submit projects on federal aid eligible roads for consideration of federal funds. Berkshire County towns have been contacted to submit new projects and updated information on existing, previously submitted projects. Towns need to submit this information by February 2, 2024.

Once project information is received, it is compiled, and the process continues with project evaluations. BRPC and MassDOT staff facilitate the TIP development process and assist the Transportation Advisory Committee (TAC) and the Metropolitan Planning Organization (MPO) in deliberations. The process continues over the next three months. By April 2024, a compilation of projects will be prepared, and with the concurrence of the MPO, a public comment period will be initiated on the draft TIP. Following the conclusion of the public comment period, the MPO is tentatively scheduled to endorse the TIP at their meeting on May 28, 2024.
