Bids must be submitted through the online procurement portal no later than **Wednesday**, **April 23, 2025** at **1PM**. Bids will then be opened publicly and read aloud via Zoom.

All bids for services are subject to the prevailing wage rates as per Massachusetts General Laws Chapter 149, Section 26 to 27F inclusive and Chapter 30, Section 39M. A 5% bid deposit, in the form of a bid bond or certified check, is required unless specified in the bid package.

All bidders must be pre-qualified by MassDOT for the following approved classes of work:

- 1. FY26-06 Guardrail Installed with an estimated value of \$545,409.00
- 2. FY26-07 Line Painting with an estimated value of \$557,229.00
- 3. FY26-08 Pavement Surfacing with an estimated value of \$3,977,948.00
- 4. FY26-09 Pavement Surfacing with an estimated value of \$394,677.53
- 5. FY26-10A Pavement Surfacing with an estimated value for the following county subsections:

1. Central: \$995,804.85

2. South: \$1,460,096.05

- 6. FY26-18 Catch Basin Cleaning & Line Jetting with an estimated value of \$245,471.60
- 7. FY26-19 Tree Work with an estimated value of \$566,055.00
- 8. FY26-20 Street Sweeping with an estimated value of \$57,050.00
