VI. Items Requiring Action

A. Vote to Approve the Submission of a Grant Application (after the fact) to the RIZE Mosaic Family Resilience Grant to establish a scalable low-threshold housing and service delivery model to address the growing crises of Opioid Use Disorder (OUD), social isolation and homelessness*

The Executive Committee was requested to authorize the Executive Director, after the fact, to submit a grant application to the RIZE Mosaic Family Resilience Grant and sign any resulting contracts and agreements. This grant would establish a scalable low-threshold housing and service delivery model to address the growing crises of Opioid Use Disorder (OUD), social isolation and homelessness. The partners would pilot a cluster-site of 25 "tiny-house" units to empower family and social structures, integrating harm reduction, peer support and navigation that meet familial/social units where they are at. This three-year grant allows for funding of \$500,000 per year (\$1.5M total). Expected key partners include Berkshire Health Systems/ Berkshire Harm Reduction, Hearthway, Inc and the City of Pittsfield. There is no match required. There would be subcontractors/subrecipients. <u>CHoss@berkshireplanning.org</u>. Tom reported this grant application is an example of BRPC looking to diversify sources of funding.

Doug McNally moved to authorize the Executive Director to submit a grant application, after the fact, to the RIZE Mosaic Family Resilience Grant and sign any resulting contracts and agreements. Buck Donovan seconded the motion. B. Vote to Approve the Submission of a Grant Application (after the fact) to the Massachusetts Environmental Trust (MET) for the development of a watershed-based plan for the upper Hoosic River watershed *

The Executive Committee was requested to authorize the Executive Director to submit a grant application (after the fact) to the Massachusetts Environmental Trust (MET) for Environmental Advocacy, Educational and Conservation Activities Focused on Improving Aquatic Habitats and to sign any resulting contracts and agreements.

BRPC's Environmental and Energy team are applying for a \$50,000 grant in partnership with Hoosic River Watershed Association (HooRWA), Taconic Chapter of Trout Unlimited, and MCLA to support the development of a watershed-based plan for the upper Hoosic River watershed. This project will include grassroot level environmental initiatives, public education, and citizen involvement activities that are fully inclusive and address the needs and interests of citizens in low-income or "environmental justice" communities.

The partners would work together to support the mapping of a portion of North Adams stormwater infrastructure, begin to identify sources of pollution and the most appropriate sites for green infrastructure and engage the community through outreach events such as River Fest, river cleanups and water quality monitoring. MCLA's GIS class will use this as a project-based learning opportunity and the students will work with BRPC and their Professor to map outfalls and catch basins. This application has no BRPC match requirement. Primary staff contact is Alison Dixon adixon@berkshireplanning.org.

C. Vote to Approve the Submission of a Grant Application (after the fact) to the National Fish and Wildlife Foundation Long Island Sound Futures Fund to support the installation of a stormwater management system at Francis Avenue in Pittsfield

The Executive Committee was requested to authorize the Executive Director (after the fact) to submit a grant application to the National Fish and Wildlife Foundation's Long Island Sound Future Fund grant and to sign any resulting contracts and agreements.

BRPC's Environmental and Energy team are applying for a \$266,730.06 grant in partnership with the City of Pittsfield to support the installation of a stormwater management system at Francis Avenue. This project will remediate stormwater, control flooding, and support the larger improvement of connections to downtown resources through the Francis Ave. Parklet and Routing Project.

This project has secured partial funding through the Mass DEP Section 319 Program and has applied for additional funding through EEA Municipal Vulnerability Preparedness Program. This application has a 50% match that is expected to be covered by overlapping EEA MVP Grant funds. Primary staff contact is Courteny Morehouse, cmorehouse@berkshireplanning.org.

D. Vote to Approve the Submission of a Grant Application (after the fact) to the Safe Streets and Roads for All (SS4A) Grant program with the Federal Highway Administration (FHWA) to develop and implement a safety countermeasure toolbox informed by the Berkshires' existing Safety Action Plan

The Executive Committee was requested to authorize the Executive Director (after the fact) to submit a grant application to the Safe Streets and Roads for All (SS4A) Grant program with the Federal Highway Administration (FHWA) to develop and implement a safety countermeasure toolbox informed by the Berkshires' existing Safety Action Plan and to sign any resulting contracts and agreements.

BPRC seeks SS4A Supplemental Planning and Demonstration grant funding to develop a safety countermeasure toolbox informed by the Berkshires' existing Safety Action Plan. This toolbox will then be applied to 12 demonstration sites across the County to show its versatility and ability to bring systemic safety to the region. BRPC segments the County into six

subregions: North, North-Central, Southeast, Southwest, the City of North Adams, and the City of Pittsfield. Each subregion will host two demonstration projects, while all subregions will benefit from supplemental educational and outreach activities that promote data transparency.

BPRC will obtain support from Citian CRASH, a cloud-based software-as-a-service platform, which will use real-time traffic safety data to understand the impacts of the supplemental planning and demonstration activities and facilitate long-term reporting. BPRC will also conduct a comprehensive outreach and education campaign in conjunction with the demonstration activities.

Proposed treatment solutions address these safety concerns, in addition to pedestrian and bicycle safety. Chicanes, speed feedback signs, and speed humps will mitigate single-vehicle and rear-end crashes. Medians and roundabouts will reduce instances of angle crashes. Finally, curb extensions, high-visibility crosswalks, and rectangular rapid flashing beacons (RRFBs) will enhance safety for pedestrians and bicyclists.

The total grant budget is \$2,487,100. The Federal share requested is \$1,989,680 with Non-federal match of \$497,420 provided by the Massachusetts Federal Funds Infrastructure Funds Office. Primary staff contact is Nick Russo, nrusso@berkshireplanning.org.

BRPC received notice of an Environmental Notification Form for the Parker Pond Dredging Project in Pittsfield. This is expected to be noticed in the Environmental Monitor on June 25, 2025. Parker Pond is approximately 1 acre on a residential property. The primary reason for the ENF is proximity to Environmental Justice neighborhoods. We are following the Environmental Review Committee process, but there does not appear to be any regional impacts and most likely we will not submit comments. The previous Environmental Review Committee Chair, Roger Bolton, assisted with the Parker Pond notice.

C. Finance Committee

D. Regional Issues Committee

Adams, Ashland Street from FFY 25 to FFY 2026 and move Egremont, Mt. Washington Road from FFY 26 to FFY 25, and a presentation on the micro-transit feasibility study. E. Seasonal Communities Advisory Council Update

The Executive Office of Housing and Livable Communities (EOHLC) is holding three virtual listening sessions in June and July. Established by the Affordable Homes Act in August 2024, the Seasonal Communities Designation is designed to provide a unique set of housing tools to communities with significant seasonal variation in housing and employment. F. Passenger Rail

- West-East Rail The Pittsfield double tracking project will start design soon. A planning exercise will be initiated soon to determine the best way to get a second platform at the Pittsfield station.
- <u>Berkshire Flyer</u> The Berkshire Flyer train will not run for several weeks due to track repairs. Bus service will be provided east of Albany.
- Northern Tier Passenger Rail A proposal to submit this service to the Federal Rail Administration Corridor ID program is being held up due to uncertainty with the announcement of that grant program.

G. Berkshire Microtransit Study: Upcoming Community Open Houses

Previous Studies have identified limited access to public transportation and first/last-mile connections as major transportation barriers in the Berkshires. Microtransit, an app-based, on-demand shared-ride public transit service, has been explored to overcome these barriers and enhance mobility. BRPC has sponsored a feasibility study to evaluate the potential of a Microtransit program in Berkshire County. There will be community open houses on July 18th and 19th in North Adams, Pittsfield, and Lenox, to enable the public to learn more, ask questions, and share ideas. (Flyer was attached.) H. EOHLC Office Hours on Accessory Dwelling Units

The Massachusetts Executive Office of Housing and Livable Communities is holding ADU office hours, beginning this June, to support municipal planners in understanding Massachusetts' new Accessory Dwelling Unit (ADU) law and regulations, which became fully effective as of February 2nd, 2025. These office hours began June 11th (3:00pm to 4:30pm) and will continue every second Wednesday through November. These sessions will provide an opportunity for planners to engage with EOHLC and ask questions about the new law and regulations. I. Public Comment Period for the Starter Home/Chapter 40Y Draft Regulations

A "starter home" is a smaller single-family home suitable for first-time home buyers, downsizing, smaller households, and people needing a more affordable single-family housing option. Chapter 40Y sets up a process for communities to create Starter Home Zoning Districts, where starter homes can be built. The Starter Homes Draft Regulations, 760 CMR 69.00: Starter Home Zoning Districts (download), are intended to provide clarity on the administration of M.G.L. c40Y, the Starter Home law. The public comment period on the draft regulations starts on June 20, 2025, and closes on July 25, 2025. Comments can be submitted at www.mass.gov/starterhomes. EOHLC intends to issue final regulations in early fall 2025.

J. 2025 State of the County Update

Since the development of the State of the County Report in 2022, Berkshire Benchmarks, an initiative of BRPC, has published an annual update, tracking specified socio and economic indicators, numeric tools that track the health and vitality of a region over time. The 2025 State of the County Report is available at State-of-the-County-Report-2025.pdf

K. Massachusetts Integrated Land Use Strategy

On Behalf of MARPA, the Massachusetts Association of Regional Planning Agencies, the Northern Middlesex Council of Governments (NMCOG) submitted a joint application in response to an RFQ from the Executive Office of Energy and Environmental Affairs regarding consulting services to develop the Massachusetts Integrated Land Use Strategy (MILUS). This proposal involves all RPAs in the Commonwealth, to varying degrees. NMCOG and Merrimac Valley Planning Commission (MVPC) have led a working group involving BRPC and a small group of RPAs to develop a collaborative approach to address the state's needs. If the MARPA partnership is selected, BRPC will co-lead an economic development working group with the Central Massachusetts Regional Planning Commission and will also be involved in several project tasks that call for all RPAs to participate, including the development of an interactive GIS-based planning tool to visually explore the intersection of state and local plans, policies, and regulations.

- <u>Berkshire Flyer</u> Amtrak has issued an official notice indicating that Berkshire Flyer train service will be replaced by buses between Albany and Pittsfield for the duration of its seasonal service.
- Northern Tier Passenger Rail No new information is available on the grant funding announcement for the Corridor ID program. MassDOT Office of Transportation is working with FRCOG to prepare a contract to fund the procurement of a consultant to conduct an Economic Impact Analysis.

F. MassDOT LEAP Program

MassDOT has launched the Local Early and Actionable Planning (LEAP) program to help municipal officials jump-start infrastructure projects, providing planning and early-stage design assistance to towns and cities across Massachusetts, with a particular focus on rural and economically disadvantaged communities. G. AGO Dover Amendment Guidance and EEC Notice of Change to the Dover Amendment, M.G.L. c.40A, § 3

The Attorney General's Office has released a <u>comprehensive guidance</u> <u>document</u> to assist communities in understanding the exemptions provided to religious and educational uses through MGL Chapter 40A, Section 3, also known as the "Dover Amendment." Additionally, communities should be aware of a change made to Section 3 in July of 2024 as part of the approval of the FY2025 state budget. Section 3 was amended to include explicit language providing zoning protections to family child care homes and large family child care homes. The language officially reads: "Family child care home and large family child care home as defined in section 1A of chapter 15D shall be an allowable use and no city or town shall prohibit or regulate such use in its zoning ordinances or by-laws.". A summary is included in the meeting material packet.

H. MA Building Decarbonization Clearinghouse Final Report and upcoming Mass Save Reforms Webinar

Jury Duty Policy



Policy

Employees serving on jury duty will be granted leave for the entire length of the trial. BRPC will pay the employee for the first three days of the trial, an amount equal to the difference between the compensation paid for the normal working period and the amount paid by the court, excluding allowance for travel. The amount due the employee shall be paid upon presentation of proper evidence for monies received for jury duty. After the first three days, the employee may, but is not required, to use their accrued leave to continue receiving pay while serving. Employees will not be given mandatory work assignments that interfere with jury duty.

Military Leave Policy



Policy

BRPC intends to comply with all applicable provisions of the Uniformed Services Employment and Reemployment Rights Act. Employees who are absent from employment due to service in the Uniformed Services will remain employed and be restored to their position of employment upon their return. Uniformed Services comprises the Armed Forces, the Army National Guard, the Air National Guard, the commissioned officer corps of the Public Health Service and the National Oceanic and Atmospheric Administration, members of the National Disaster Medical Service, members of the National Urban Search and Rescue System, and FEMA Reservists.

During the employee's period of absence, they will not be subjected to loss of seniority, service, or benefits. Employees may elect to continue existing BRPC health plan coverage for themselves and their dependents for up to 24 months while in the military.

Individuals who are currently or have previously been members of the Uniformed Services, or individuals who have applied for membership in the Uniformed Services, shall not be subjected to discrimination with regard to hiring, re-employment, retention in employment, promotion, or any employment benefit because of their Uniformed Services membership status.

While on leave, an employee may choose to use accrued paid time off to continue to be paid, except for sick leave, since sick leave may not be used for non-illness-related reasons.

Veteran's Leave Policy



Policy

An employee who is a veteran or a member of a department of war veterans listed in G.L. c. 8, § 17 shall be granted unpaid leave to participate in Memorial Day exercise, parade, or service in the employee's community of residence.

An employee who is a veteran or a member of a department of war veterans listed in G.L. c. 8, § 17 shall be granted unpaid leave to observe Veterans Day.

This section shall not apply to employees whose services are essential and critical to the public health or safety and determined to be essential to the safety and security of BRPC or its property.

MassDOT Launches New Initiative to Support Transportation Planning in Rural and Underserved Communities

Total of \$1 million available from LEAP Program to support early-stage design needs for municipal transportation projects

BOSTON — The Massachusetts Department of Transportation (MassDOT)'s Office of Transportation Planning (OTP) is launching the Local Early and Actionable Planning (LEAP) Program to help municipal officials jump start infrastructure projects. The LEAP Program will provide planning and early-stage design assistance to towns and cities across Massachusetts with a particular focus on rural and economically disadvantaged communities as these communities often face significant barriers when it comes to initiating transportation projects due to limited funding and staffing. The funding, totaling approximately \$1 million, is included in Governor Healey's Capital Investment Plan this year and will be funded as part of MassDOT's capital budget for FY 2026.

"Our goal is to empower community leaders with the tools and support they need to bring priority projects to life," said **Transportation Secretary and CEO Monica Tibbits-Nutt**. "Through the LEAP Program, we're helping local governments take

that critical first step—positioning them to secure the resources needed to advance transportation projects that make streets safer, more connected, and more accessible for everyone, whether they're walking, biking, riding transit, or driving."

The LEAP Program is structured in a way that allows municipal staff to request the support they need for early-stage planning and design activities, including, but not limited to:

- Conceptual Design and Alternatives Analyses, for example, hydraulic and geotechnical analysis.
- Safe Streets Network Strategy
- Design & Engineering for Smaller-Scale Projects (e.g. Complete Streets Program Projects)
- Federal Grant Application Development
- Safety Analysis, for example, conduct crash pattern evaluation
- Traffic Analysis, for example, collect traffic volume data
- Speed Studies
- Cost Estimation
- Visual and Mapping Support

The total amount available statewide in Fiscal Year 2026 for the LEAP Program is \$1 million. MassDOT anticipates providing municipalities with approximately \$25,000 to \$100,000 per project. The focus of LEAP is on helping under resourced communities access federal and state transportation funding programs.

To help local officials and stakeholders learn more about the LEAP Program and application process, MassDOT staff will be presenting at a series of public

NOTICE OF CHANGE TO THE DOVER AMENDMENT, M.G.L. c. 40A, § 3

As part of the FY25 enacted budget signed by Governor Healey on July 29, 2024, changes were made to the so-called Dover Amendment, M.G.L. c. 40A, § 3.

The amended Section 3 reads:

Section 3 of chapter 40A of the General Laws, as so appearing, is hereby amended by striking out the fifth paragraph¹ and inserting in place thereof the following paragraph:-

Family child care home and large family child care home as defined in section 1A of chapter 15D shall be an allowable use and no city or town shall prohibit or regulate such use in its zoning ordinances or by-laws.

M.G.L. c. 40A, § 3 (emphasis added).² As detailed above, the Legislature has amended G.L. c. 40A, § 3 to explicitly provide that family child care homes and large family child care homes are an <u>allowable</u> use, which <u>shall not be prohibited or regulated</u> by a city or town's zoning ordinances or by-laws.
