## **I. Call to Order – Introductions**

**IV. Approval Consideration of an amendment (3rd Amendment) to the FFY 2026-2030 TIP for the following: HIGHWAY SECTION – FFY 2026, Project 610728 Lee, resurfacing and related work on Route 20, reduce funding by \$2,622,178; Project 612168 Pittsfield Bridge Replacement, P-10-040, Pontoosuc Ave over West Branch Housatonic River Reservoir, remove project and funding in the amount of \$9,848,718; add same project (Project 612168) to FFY 2028 and funding in the amount of \$10,016,001 and authorize staff to conduct a 21-day public comment period**

Ms. Koirala presented the proposed third amendment to the FY 2026 TIP, describing changes in the amendment, including a cost reduction for the Lee Route 20 resurfacing and related work project based on 100% design, and moving the Pittsfield Pontoosuc Ave bridge replacement from FY26 to FY28 due to readiness. Mr. Fick requested clarification on Pittsfield’s bridge replacement, which Ms. Koirala and Mr. Shooster reiterated had been delayed from FY26 to FY 28.

**V. Receive the draft 2027 – 2031 Transportation Improvement Program and authorize staff to conduct a 21-day public comment period**

Ms. Koirala introduced the Draft FFY 2027–2031 TIP and noted it is a five-year document updated annually and posted online. Mr. Shooster noted the project lists had been presented comprehensively at prior meetings and had not changed, and invited questions from members. Ms. Lambert noted a cover detail referencing “2026,” which Ms. Koirala clarified the federal fiscal year start date of October 1, 2026, which corresponds to FFY 2027. Before the vote, Mr. Shooster recognized the work of staff and stakeholders and thanked Ms. Koirala specifically for assembling the TIP.

**VI. Inform the MPO of BRTA’s 2026 Community Transit Grant awards received from MassDOT**

Mr. Kus summarized that MassDOT Rail & Transit Division annually awards Community Transit Grants (FTA Section 5310), and that awards can be reflected through administrative modification rather than requiring a TIP amendment and Board vote. Ms. Koirala reviewed Berkshire-region awards including BRTA operating/mobility management items (travel training and rural senior transportation), a Pittsfield COA award, vehicle awards to BRTA and partner providers, and microtransit/last-mile awards to Great Barrington and the 14 RTA consortium. Ms. Lambert thanked MassDOT and noted the flex funding and rural senior program support would help BRTA implement new software initiatives and strengthen service delivery.

**VII. MPO endorsement of updated Critical Freight Corridor network for Berkshire County**

Mr. Griffis presented the updated Critical Freight Corridor network map, noting it had been released for a 21-day public comment period following the February meeting and that no comments were received. A motion was made and seconded to endorse the network as presented.

**VIII. Update and discussion on the FFY 2027 UPWP**

Mr. Kus provided a detailed overview of the UPWP, describing major sections and anticipated work activities, including management/certification, technical support, planning studies, active transportation, transit planning, safety, infrastructure protection/resiliency (including culverts), freight planning, scenic byways, and rail initiatives (including East-West Rail, Berkshire Flyer, and Northern Tier rail). Mr. Shooster provided feedback on acronym clarity (CMP), and suggested ensuring transit planning language supports ongoing coordination for East-West Rail efforts; which BRPC and MassDOT staff indicated support for continued coordination and technical assistance. Mr. Kus mentioned that the draft UPWP would be presented at the next meeting and that the MPO would be asked to initiate the public comment period.

**IX. Other business**

Mr. Frieri updated the MPO on FFY 2026 project status, including Sheffield County Road bridge work in construction, North Adams Veterans Memorial bridge preservation readiness, Route 8 ledge removal in Beckett, Great Barrington Division Street bridge replacement, Route 20 resurfacing in Lee with a public hearing anticipated, and North Adams Ashland Street reconstruction progressing toward advertisement;

he also noted the Pontoosuc Avenue bridge project schedule aligns with the shift to FFY 2028.

Ms. Lambert reported BRTA's route realignment effort was cancelled after identifying efficiencies through revised driver run schedules; the revised service was issued and planned to go live May 11, with the goal of significantly reducing lost trips.

Mr. Kus noted Thursday would be the final day of Tom Matuszko's leadership as Executive Director and introduced incoming his incoming replacement, Laura Brennan, who briefly addressed the board. MassDOT expressed appreciation for Mr. Matuszko's service and welcomed Ms. Brennan, offering support for onboarding in transportation efforts.

#### **X. Next Meeting date – May 26<sup>th</sup>, 2026**

The next MPO meeting is scheduled to be held on May 26, 2026.

**ACTION:** Mr. Shanahan motioned to adjourn, seconded by Ms. Bonbrake. Mr. Shooster adjourned the meeting at 4:55 p.m.
